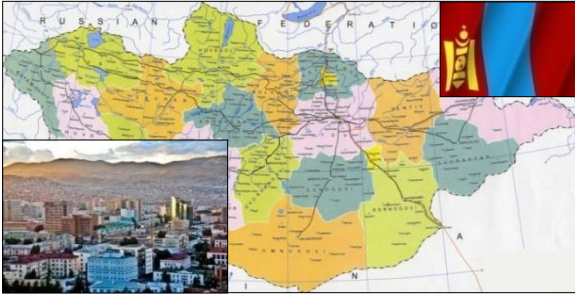

Mongolia – El Dorado in the steppe

The projections for mid-term to long-term economic development in Mongolia are impressive. Under the existing economic conditions, the Mongolian GNP will grow 14 % annually on average until 2016. The per capita income will likely more than double by 2021, from 5,000 USD today to 12,000 USD.
